The broad categories under which the nominees will be evaluated are the following:

Part 1: Nature of the business being transacted between the two countries.

Please describe the business being conducted between Canada and South Africa by the nominee. This could involve importing, exporting, investments, joint ventures, technology transfers and innovative projects. Factors to be considered might include the nature of the business, markets being served and growth rate and how long the nominee has been doing business in South Africa or Canada, as the case may be.

Part 2: Socio-Economic Impact.

Does the individual and business activity with South Africa support the objectives of transforming South African society as a whole? This includes the promotion of historically disadvantaged individuals (black economic empowerment, promotion of women), capacity building, skills and training development, community development (physical infrastructure), health improvement, etc.

Part 3: An Advocate for Business.

Is the nominee a positive role model for business interaction between Canada and South Africa? For example is the nominee supportive of initiatives by governments, non-government associations and trade associations and other businesses to further strengthen economic relations and interactions between Canada and South and Southern Africa.

Considerations.

The nominee must be a Canadian resident. Business activity is not limited to only Canada and South Africa but could also include sub-Saharan Africa. Please feel free to expand or provide additional information or supporting documents as attachments to the nomination form.
